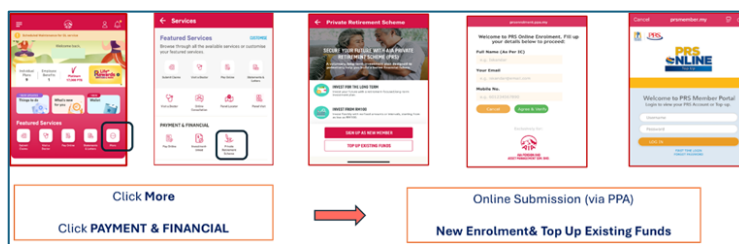

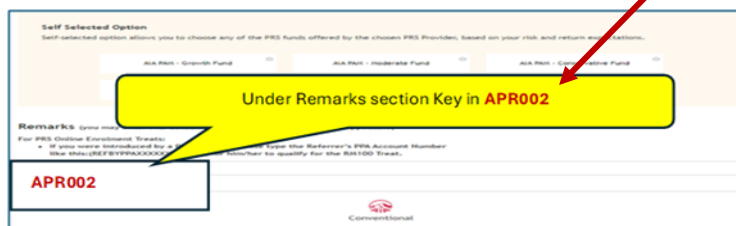

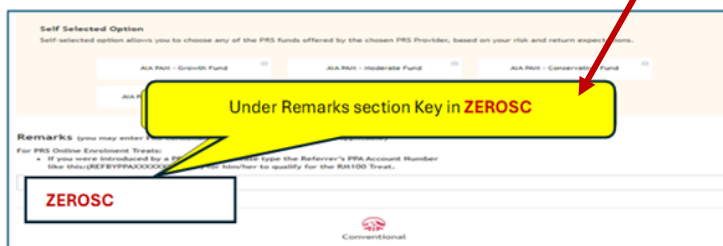
2. To access new fund, please click as New Enrolment (for both New & Existing AIA PRS Customer)
3. Please take note that only your existing funds will appear when you click under Online Top-Up

5. Agents **without** AIA PRS Consultant License must enter **APR002** at the Remark Column during the online submission to qualify for this campaign and Zero Sales Charge.



6. Agents **with** AIA PRS Consultant License must enter **ZEROSC** at the Remark Column during the online submission to qualify for this campaign and Zero Sales Charge.



7. The maximum contribution limit for Online Enrolment is RM3,000.
8. For contributions exceeding RM3,000 to the new fund, agent may log in again under Online Enrolment to make a second contribution (up to a maximum of three times on the same day).



9. Creation of new fund may take up to 7 working days to reflect in the customer's PPA member portal.
