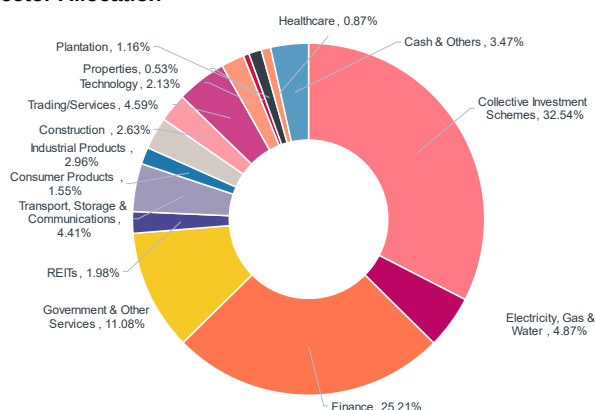

Sector Allocation



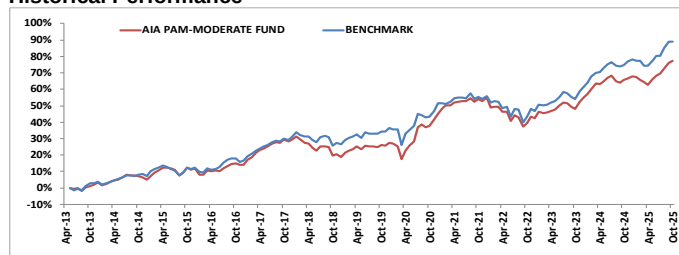
Risk

Market Review

Malaysian Government Securities ("MGS") yield curve bear steepened in October 2025, with the sell-off initially triggered by a disappointing 30-year MGS 7/55 reopening auction. The market weakness was compounded later by a strong 3Q25 advanced GDP estimate, which dampened expectations of a further rate cut by BNM, as well as a weak 20-year MGS 5/44 auction towards the end of the month. The 25-bps cut by the US Federal Open Market Committee ("FOMC") failed to lift sentiment as US Federal Reserve Chair Jerome Power sounded more hawkish than expected in the post-FOMC meeting press conference. Some dip-buying eventually emerged, which led to the partial recovery in yields.

In October, the S&P 500 gained 2.3%, supported by the US Federal Reserve's second 25 bps rate cut of the year, bringing the target range to 3.75-4.00%. Easing trade tensions and a solid earnings season further buoyed the index, despite headwinds from the ongoing US government shutdown and lingering tariff concerns. In the ASEAN equity space, the MSCI Asia ex-Japan index advanced 4.5%, driven by strong gains in Korea and Taiwan's technology and industrial sectors, which surged 19.9% and 9.3% respectively. The rally was underpinned by sustained optimism around the AI theme, despite mounting concerns over a potential bubble.

The FBMKLCI ("Index") fell 0.2% Month-on-Month ("MoM") to close at 1,609 pts in October 2025. The Index underperformed the MSCI Asia ex Japan Index, which gained 4.4% MoM in Malaysian Ringgit ("MYR") terms over the same period. Foreign investors were net sellers of Malaysian equities with net sell flows of MYR2.73 billion while local institutions remained net buyers amounting to MYR3.60 billion during the month.

Market Outlook

While external risks persist, Malaysia's proactive policy measures and resilient domestic fundamentals provide a constructive backdrop for the local market heading into 2026. A dovish global monetary stance, particularly from the U.S. Federal Reserve, is likely to support ringgit and foreign inflows. BNM will likely keep the OPR unchanged as it awaits more economic data to guide its next policy move. Volatility is likely to persist in the near term as markets react to further developments in trade negotiations and key economic data releases. We continue to adjust the portfolio proactively to manage risks and capture opportunities as they arise.
